### **Terms and Conditions**

1. The child shall comply with any reasonable instruction or request from the company, its servants or agents, necessary to the child's safety and well being and the proper conduct of the journey.
2. The child shall be met at the disembarkation point by the responsible adult, described above, and in the event of that person being unknown to the child, satisfactory proof of identity shall be produced.
3. Parents or guardians must be at coach stop 30 minutes before expected arrival time.
4. Should the child become ill the Company reserves the right to take whatever action it deems necessary to ensure the comfort and safety of the child, all costs associated with such action will be borne by the child's custodial parent/s or guardian/s.
5. The child shall be provided with adequate funds for meals en route.
6. The Company shall not be held responsible for any loss or damage incurred by the child as a result of late boarding or failure to board either at the initial boarding point or at any intermediate stopover point.
7. The Company will only disembark the child at a scheduled stopping point as detailed in its official timetable or any amendments thereto from time to time in force.
8. A person must be 15 years and over to be in charge of a child under the age of 10 years.
9. No responsibility will be accepted by the Company for unaccompanied children whilst in transit, however, all care will be exercised where possible.
10. Children under the age of seven (7) years will not be carried unless accompanied by an adult guardian.

These conditions shall be read in addition to the Company's standard conditions of carriage and shall in no way alter, waive or modify those conditions. In consideration of the Company agreeing to carry the passenger described above (being an unaccompanied minor) I accept and agree to the conditions set out in 1 to 10 above and hold the Company indemnified against any loss or damage it is or may be liable for as a result of any act of omission or commission by the passenger.
